¹This listing is based on an exhaustive analysis of relevant state records over the last four years and a follow-up survey of those research institutions identified as having purchased random source dogs and cats from Class B dealers during that time span. Five institutions responded to the survey by indicating that they do indeed purchase random source dogs and cats from Class B dealers or reserve the right to do so. Forty-five failed to respond, despite repeated attempts, raising the strong suspicion that they too continue to make such purchases or reserve the right to do so. Our analysis may not have detected all research institutions that purchase random source dogs and cats from Class B dealers (or reserve the right to do so), especially if they have begun to make such purchases only recently.
