INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(e)(2) - Institutional Animal Care and Use Committee. A proposal to conduct an activity involving animals, or to make a significant change in an ongoing activity involving animals, must contain a rationale for involving animals, and for the appropriateness of the species and numbers of animals to be used.

- The amendment to protocol number 2617 did not provide an adequate rationale for the increase in the number of animals to be added to the study. The justification was "However at the early stage of this study, we need about 25 experiments to confirm the experimental system due to technical issue. Currently we do not have any technical issue. Therefore we need at least 25 additional experiments to get data." The number of animals required should be clearly and scientifically justified to assure that no more animals are used than are necessary for scientific validity. All proposals or amendments to proposals to conduct an activity involving animals must contain a rationale for the numbers of animals to be used and the rationale must be made available to the inspector at the time of inspection. This affects the additional animals used in the study.
