Sec. 3.26 Facilities, indoor. (d) Interior surfaces. The interior building surfaces of indoor housing facilities shall be constructed and maintained so that they are substantially impervious to moisture and may be readily sanitized.

Guinea Pig room: There are several small patches where the paint is missing or pealed off the sheet rock (on the left -south-wall). This is necessary to have the surface to be substantially impervious to moisture and may be readily sanitized. Implementing a maintenance program would ensure that repairs would be documented and completed in a timely manner.

Pen # 02 and #11 Goat Pen: The feed bunks, on the right side, there is split board of about 1/2 inch wide and the length of the side. These areas are to have integrity to keep the feed in and to prevent possible contamination. This is important to maintain a healthy environment for the animals. This is needed to facilitate the prescribed husbandry practices and to protect the health of the animals..

To keep the feed bins in tact, a program of regular maintaince would keep the area repaired.

Rabbit Building One: On north side of the building: One window is broken and two windows are missing. One of the missing window areas has an old feed sack covering it. Windows need to be in present and in good repair so air flow can be adjusted and maintained. Also, properly maintained windows will keep out potential predators, rodents, etc.

Goat Barn: Pen 7: A "kick board" at the bottom of the door to pen 07 was detached from the bottom of the entry door. It was lying on the ground.

The disposal facilities and any disposal of animal and food wastes, bedding, dead animals, trash, and debris shall comply with applicable Federal, State, and local laws and regulations relating to pollution control or the protection of the environment.

Goat Food Storage Area (North end of barn): A wheel barrow full of old food was present. There was approximately ? bucket of old food scattered around on the ground.

Front Goat Barn pathway: About a ? bucket of old feed was scattered about in front of the pens on the sidewalk.

Goat Barn: yard area behind pen #1- pen #7: There is a depression accumulating water during the rain storms. It is approximately 50 feet long and 15 feet wide. There are several smaller holes with water in them. There is no method to rapidly drain the water from the various holes. A temporary fix would be to dig a drainage ditch to the other drainage ditch near by. A more permanent fix (in the summer) is to bring in fill and slope the area so it drains properly

? 3.129 Feeding. (a) The food shall be wholesome, palatable, and free from contamination and of sufficient quantity and nutritive value to maintain all animals in good health. The diet shall be prepared with consideration for the age, species, condition, size, and type of the animal. Animals shall be fed at least once a day except as dictated by hibernation, veterinary treatment, normal fasts, or other professionally accepted practices.

Goat Barn: Pen #8: Salt block on the ground with fecal material underneath and around it. The block needs to be in a rack off the ground so it isn't soiled.

This was corrected during inspection.

Goat Barn: All feed bunkers need to be checked for chicken feces. Occasional droppings were found on the pelleted feed. Nutritious clean uncontaminated feed is important to maintain the health of the animals.

These birds were observed eating the food in the area and had left fecal droppings in the feed bunks. Removal of the birds and the fecal material from the feed bunks is necessary to prevent contamination and potential illness in the animals.
