#### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

(b) Each research facility shall establish and maintain programs of adequate veterinary care that include:

(1) The availability of appropriate facilities, personnel, equipment, and services to comply with the provisions of this subchapter;

-A dog on medication do not have an identification on the cage card and in the medical records, route of medications are not indicated.

#### HOUSING FACILITIES, GENERAL.

(e) Storage. Supplies of food and bedding must be stored in a manner that protects the supplies from spoilage, contamination, and vermin infestation. All food must be stored in a manner that prevents contamination and deterioration of its nutritive value. All open supplies of food and bedding must be kept in leakproof containers with tightly fitting lids to prevent contamination and spoilage.

-Three open bags of feed and bedding materials were noted in the feed room. Mice, insects and other rodents may enter the feed bags and may contaminate the feed with their urine and feces. Facility shall ensure that open supplies of food and bedding are kept in leakproof containes with tightly fitting lids to prevent contamination. CORRECT BY END OF DAY DECEMBER 10, 2009.

### PRIMARY ENCLOSURES.

- (2) Primary enclosures must be constructed and maintained so that they:
- (v) Enable the dogs and cats to remain dry and clean;

-Bedding materials are thinly spread on the floor without any other elevated resting/sleeping platform in at least four rooms. Dogs are in direct contact with feces and can be contaminated with these materials. Also, dogs won't be able to remain dry and clean during room cleaning. Facility shall ensure that dogs are kept in rooms that affords protection from any contamination and can remain dry and clean at all times.

-An open bag of bedding material, left from the previous day is noted in the storage room. Leftover bedding materials shall be kept in a container with tight fitting lid to prevent from contamination or vermin infestation. Facility shall ensure that food and bedding material are properly stored.
