ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

Sec. 2.33 Attending veterinarian and adequate veterinary care. (a) Each research facility shall have an attending veterinarian who shall provide adequate veterinary care to its animals in compliance with this section:

Definition of attending veterinarian: Attending veterinarian means a person who has graduated from a veterinary school accredited by the American Veterinary Medical Association's Council on Education, or has a certificate issued by the American Veterinary Medical Association's Education Commission for Foreign Veterinary Graduates, or has received equivalent formal education as determined by the Administrator; has received training and/or experience in the care and management of the species being attended; and who has direct or delegated authority for activities involving animals at a facility subject to the jurisdiction of the Secretary.

The attending veterinarian does not meet the definition for an attending veterinarian. This person is a graduate of a foreign veterinary school that is not accredited by the AVAMA (this was determined by looking at the AVMA website), does not have a certificate from the AVMA, and has not submitted information and approval of the Administrator.

This was corrected during the inspection. There are four veterinarians at the facility, so one was appointed by the Institutional official before this inspector left.
