ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

Sec. 2.33 Attending veterinarian and adequate veterinary care.

(b) Each research facility shall establish and maintain programs of adequate veterinary care that include:

(3) Daily observation of all animals to assess their health and well-being; Provided, however, That daily observation of animals may be accomplished by someone other than the attending veterinarian; and Provided, further, That a mechanism of direct and frequent communication is required so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian.

According to a staff member, three rabbits became ill and died during the last approximately eighteen months. The attending veterinarian was never consulted or notified that the animals were sick. There were no medical records or documentation identifying dates or signs of illness available for review at the time of the inspection. Daily observations of all animals to assess their well-being, appropriate documentation of those observations, and direct and frequent communication with the attending veterinarian regarding health issues are necessary to ensure that the animals at the facility receive timely and adequate veterinary care. A system should be in place to ensure that all animals are observed daily, any health problems are documented, and the attending veterinarian is notified when necessary.

A system should be in place to ensure that the minutes are available for review in a timely manner in order to ensure that the facility is in compliance with the applicable Animal Welfare Act regulations.

3.56 Sanitation.

(c) Housekeeping. Premises (buildings and grounds) shall be kept clean and in good repair in order to protect the animals from injury and to facilitate the prescribed husbandry practices set forth in this subpart. Premises shall remain free of accumulations of trash.

The floor around the rabbit cages was not clean at the time of the inspection. A small amount of rabbit feces and what appeared to be dried urine were present under and immediately surrounding the rabbit cages. Areas of peeling paint were also observed on the floor near the rabbit cages. Additionally, ground dried food was observed on a table next to the cages and on the floor near the table where food pellets were being ground in a large coffee grinder.

Failure to keep the premises clean and in good repair may result in the attraction of vermin and increase the risk of disease. A system should be in place to ensure that the floor is repaired and kept clean and that any spilled food is cleaned up in a timely manner in order to facilitate the prescribed husbandry practices that are set forth in this subpart.
