#### CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

(c) Housekeeping for premises. Premises where housing facilities are located, including buildings and surrounding grounds, must be kept clean and in good repair in order to protect the nonhuman primates from injury, to facilitate the husbandry practices required in this subpart, and to reduce or eliminate breeding and living areas for rodents, pests, and vermin. Premises must be kept free of accumulations of trash, junk, waste, and discarded matter.

\*\*\*At time of inspection the following were noted in laboratory areas: 1) There was a transport cart with a mild to moderate accumulation of dust on it being stored in the hallway area. 2) Forceps used for delivering food rewards had a mild to moderate accumulation of food caked on them. 3) A refrigerator had a leaking container of apple juice in it. This was corrected at time of inspection. 4) There was general clutter, including storage areas. Animal areas should be kept clean to facilitate the husbandry practices required by The Act.\*\*\*
