### FACILITIES, GENERAL.

(d) Waste disposal. Provisions shall be made for the removal and disposal of animal and food wastes, bedding, dead animals, and debris. Disposal facilities shall be so provided and operated as to minimize vermin infestation, odors, and disease hazards.

\*\*\* Upon entering a guinea pig room, a moderate to strong odor of animal waste was noted. There were 2-4 empty guinea pig enclosures with a small accumulation of animal waste in one corner of each of the enclosures. The accumulation of animal waste, even for a short period of time, may lead to vermin infestation, odors and disease hazards. Enclosures should be cleaned after each animal is removed from a study to minimize the build up of odors.\*\*\*
