The protocol did not contain any explanation or rationale for the numbers of animals used. It is important for the IACUC committee to allow only the use of animals that are necessary for use in research studies. Approval of numbers of animals without a justification or rationalization does not meet the above regulation and may allow for unnecessary use of animals by researchers.

### MISCELLANEOUS.

Access and inspection of records and property. (1) Each research facility shall, during business hours, allow APHIS officials: (b) Access and inspection of records and property. (i) To enter its place of business;(ii) To examine records required to be kept by the Act and the regulations in this part;(iii) To make copies of the records; (iv) To inspect the facilities, property, and animals, as the APHIS officials consider necessary to enforce the provisions of the Act, the regulations, and the standards in this subchapter; and (v) To document, by the taking of photographs and other means, conditions and areas of noncompliance. (2) The use of a room, table or other facilities necessary for the proper examination of the records and for inspection of the property or animals shall be extended to APHIS officials by the research facility.

A responsible adult shall be made available to accompany APHIS officials during the inspection process. There was no one available with any knowledge of the animal welfare program at the facility, nor did anyone know or have access to IACUC documents required to be reviewed by APHIS officials. Animals on site and their facilities could not be inspected on this unannounced inspection.

Correct this non compliance by November 30, 2008.

**2.31** (c) (3) **REPEAT**  
**INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).**

Prepare reports of its evaluations conducted as required by paragraphs (c)(1) and (2) of this section, and submit the reports to the Institutional Official of the research facility; The reports shall be reviewed and signed by a majority of the IACUC members and must include any minority views. The reports shall be updated at least once every six months upon completion of the required semiannual evaluations and shall be maintained by the research facility and made available to APHIS and to officials of funding Federal agencies for inspection and copying upon request. The reports must contain a description of the nature and extent of the research facility's adherence to this subchapter, must identify specifically any departures from the provisions of title 9, chapter I, subchapter A--Animal Welfare, and must state the reasons for each departure. The reports must distinguish significant deficiencies from minor deficiencies. A significant deficiency is one which, with reference to Subchapter A, and, in the judgment of the IACUC and the Institutional Official, is or may be a threat to the health or safety of the animals. If program or facility deficiencies are noted, the reports must contain a reasonable and specific plan and schedule with dates for correcting each deficiency. Any failure to adhere to the plan and schedule that results in a significant deficiency remaining uncorrected shall be reported in writing within 15 business days by the IACUC, through the Institutional Official, to APHIS and any Federal agency funding that activity;

The report required to be completed under this section was not available for inspection. A copy of the rough draft was available to review. The report signed by a majority of members must be available for APHIS to review during their visits to this institution. This was previously cited on September 20, 2006 and remains unresolved as of this inspection date.
