-Nobody checks rabbits on weekends to assess their health and well-being. Veterinary care can not be provided should an emergency occurs on weekends. Facility shall ensure that rabbits are observed daily to evaluate their health and well-being.

FEEDING.

(a) Rabbits shall be fed at least once each day except as otherwise might be required to provide adequate veterinary care. The food shall be free from contamination, wholesome, palatable and of sufficient quantity and nutritive value to meet the normal daily requirements for the condition and size of the rabbit.

- Nobody works on week ends to fed and provide water to the animals. Rabbits are given the approximate food and water to be consumed over the week end on Fridays. Rabbits will not get adequate food and water in case of equipment malfunction during weekends. This could severely affect their health or possibly die from this condition.

(1) The availability of appropriate facilities, personnel, equipment, and services to comply with the provisions of this subchapter;

-Unlabeled syringe with clear liquid is noted in the work area from yesterdays work (June 29, 2009). This liquid can be mistakenly used for other purpose and may cause harm to the rabbit. Syringe must be identified, labeled and stored in a proper manner. Appropriate personnel must be available to prevent future incident and possible injury to the animal. Facility shall ensure that appropriate personnel are available to establish adequate veterinary care.

SANITATION.

(c) Housekeeping. Premises (buildings and grounds) shall be kept clean and in good repair in order to protect the animals from injury and to facilitate the prescribed husbandry practices set forth in this subpart. Premises shall remain free of accumulations of trash.

-Discarded soda bottles and cups are noted in the work area. Washing sink is also noted with hairs, dungs and cobwebs. Facility shall ensure that these areas be kept clean and remain free of accumulations of trash.
-Transport cage is covered with rabbit hairs, and wire ends protrude into cage. These wire ends may cause injury when animals rubbed their body against it. Facility shall ensure that structures and other handling fixtures in the barn are kept in good repair.
