Sec. 3.1 Housing facilities, general.

(b) Animal areas inside of housing facilities must be kept neat and free of clutter, including equipment, furniture, and stored material, but may contain materials actually used and necessary for cleaning the area, and fixtures or equipment necessary for proper husbandry practices and research needs.

\*\*\*The canine clinic room is used to perform minor procedures on dogs. At time of inspection the room was untidy. The counter tops were cluttered with medical materials and there was an opened surgical pack on the treatment table. Procedural rooms should be cleaned after each use and be maintained so as to minimize disease hazards.\*\*\*

Sec. 3.125 Facilities, general.

(c) Storage. Supplies of food and bedding shall be stored in facilities which adequately protect such supplies against deterioration, molding, or contamination by vermin.

\*\*\*There was a food bin located in the enrichment room that was filled with peanuts. The top of the bin was not securely fastened and there were approximately 10 small moths found among the peanuts. The presence of insects in food bins may contaminate its contents. The peanuts should be discarded. Food for the animals shall be stored in facilities which adequately protect such supplies against deterioration, molding, or contamination by vermin.\*\*\*
