Sec. 3.1 Housing facilities, general. (e) Storage. Supplies of food and bedding must be stored in a manner that protects the supplies from spoilage, contamination, and vermin infestation. The supplies must be stored off the floor and away from the walls, to allow cleaning underneath and around the supplies. Foods requiring refrigeration must be stored accordingly, and all food must be stored in a manner that prevents contamination and deterioration of its nutritive value. All open supplies of food and bedding must be kept in leakproof containers with tightly fitting lids to prevent contamination and spoilage. Only food and bedding that is currently being used may be kept in the animal areas. Substances that are toxic to the dogs or cats but are required for normal husbandry practices must not be stored in food storage and preparation areas, but may be stored in cabinets in the animal areas

There was one open box of dog treats (15#) . It needs to be in a closed container to help prevent contamination and vermin infestation. For the well being of the animals, food stuffs need to be in closed container to prevent contamination, and provide a healthy food for the animals.

Sec. 2.30 Registration: (a) Requirements and procedures.

(1) Each research facility other than a Federal research facility, shall register with the Secretary by completing and filing a properly executed form which will be furnished, upon request, by the AC Regional Director. The registration form shall be filed with the AC Regional Director for the State in which the research facility has its principal place of business, and shall be updated every 3 years by the completion and filing of a new registration form which will be provided by the AC Regional Director. Except as provided in paragraph (a)(2) of this section, where a school or department of a university or college uses or intends to use live animals for research, tests, experiments, or TEACHING, the university or college rather than the school or department will be considered the research facility and will be required to register with the Secretary. An official who has the legal authority to bind the parent organization shall sign the registration form.

(2) In any situation in which a school or department of a university or college demonstrates to the Secretary that it is a separate legal entity and its operations and administration are independent of those of the university or college, the school or department will be registered rather than the university or college.

(3) A subsidiary of a business corporation, rather than the parent corporation, will be registered as a research facility unless the subsidiary is under such direct control of the parent corporation that the Secretary determines that it is necessary that the parent corporation be registered to effectuate the purposes of the Act.

(b) Acknowledgment of regulations and standards. APHIS will supply a copy of the regulations and standards in this subchapter with each registration form. The research facility shall acknowledge receipt of and shall agree to comply with the regulations and standards by signing a form provided for this purpose by APHIS, and by filing it with the AC Regional Director.

### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

\*\*\*(b) Each research facility shall establish and maintain programs of adequate veterinary care that include:(2) The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries.\*\*\*

During the inspection, the following expired medical materials were identified commingled with non-expired materials. Expired materials included Heparin vials 10 mls (5) and 30 mls (4) (expired as of 9/2007), Ivermectin 0.01% oral suspension (7) (expired as of 07/2007), Isoflurane 250 mls (expired as of 11/2007), Vacuutainer tubes 4 mls (17 tubes) (expired as of 05/2007), ACT tubes 4 mls (7) (expired as of 11/2007) and biosyn suture material (4) (expired as of 09/2002). The use of expired medical materials on regulated animals does not constitute adequate veterinary care as required by the above regulation of Animal Welfare Act. The manufacturer does not guarantee the stability of the medical materials beyond its expiration date. These materials when commingled with non-expired materials increase the chances of health hazards to animals. Expired medical materials may degrade to toxic by products and may harm the animals if used on them. A system must be in place to ensure that all expired medical materials be identified, labeled and stored in an area separate from the non-expired medical materials or properly disposed of on a regular basis.
