(3) A complete description of the proposed use of the animals.

An IACUC approved protocol for an activity using cats required obtaining frequent blood samples. The protocol did not require a minimum body weight for cats included in the study. Additionally, the protocol did not establish a maximum blood volume per unit body weight that could be safely harvested from the cats. Given the wide range of normal body weights of cats, this information should have been included in the description of the activity prior to IACUC approval.

It is the responsibility of the IACUC to ensure that the investigator provides a complete description of proposed activities that involve the use of animals in order that those activities may be adequately reviewed and determined to be in accordance with the Animal Welfare Act.

Sec. 2.31 Institutional Animal Care and Use Committee (IACUC)

(e) A proposal to conduct an activity involving animals, or to make a significant change in an ongoing activity involving animals, must contain the following:

(3) A complete description of the proposed use of the animals.

One IACUC approved protocol contained an incomplete description of the proposed use of animals regulated by the Animal Welfare Act. Both the original protocol and an amendment to the protocol failed to adequately describe differences in the test articles and treatment groups that resulted in a deviation in the use of some of the animals during the activity. A more complete description of the proposed use of the animals may have prevented the protocol deviation. Deviations from an approved protocol or amendment may ultimately result in the repetition of an activity and the unnecessary use of more animals. A complete description of the proposed use of animals is also necessary in order that the IACUC may determine that the activity is in compliance with the Animal Welfare Act. It is the responsibility of the IACUC to ensure that the investigator provides a complete description of proposed activities that involve the use of animals in order that those activities may be reviewed prior to their approval.
