#### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

Repeat NCI<<Each Research facility shall establish and maintain programs of adequate veterinary care that include: The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries...>>

Several expired medical materials were found during this inspection (1 vial Fentanyl Citrate exp. 1 Aug 07, 2 vials Diazepam exp. 1 Aug 07, 1 box of 6 vials of Naloxone exp. 3/07, 1 syringe with 20 mls of Fentanyl with no expiration date, 1 syringe with 4 mls of Buprenorphine with no expiration date).

The use of expired medical materials is not considered to be adequate veterinary care since there may be unexpected results leading to increased pain or distress in the animals treated.

This is a repeat noncompliance previously cited during the inspection on 7/10/06 and with a previous correction date of 7/12/06.

### 3.1 (c) (1)

#### HOUSING FACILITIES, GENERAL.

<< Surfaces--General requirements: The surfaces of housing facilities...must be constructed in a manner and made of materials that allow them to be readily cleaned and sanitized, or removed or replaced when worn or soiled.>>

The second kennel in Rm 252 has an exposed capped drain on the back wall of the kennel where the surrounding plastic material covering the wall has been chipped. This area cannot be properly cleaned or sanitized and could potentially allow for contaminated materials to be introduced underneath the plastic material.

The surfaces of all housing facilities for dogs should be made of materials which can be readily cleaned and sanitized or be repaired or replaced when worn or soiled.
