INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

(c) IACUC functions. With respect to activities involving animals, the IACUC, as an agent of the research facility, shall:

(1) Review, at least once every six months, the research facility's program for humane care and use of animals, using title 9, chapter I, subchapter A--Animal Welfare, as a basis for evaluation;

(2) Inspect, at least once every six months, all of the research facility's animal facilities, including animal study areas, using title 9, chapter I, subchapter A-Animal Welfare, as a basis for evaluation;

(3) Reports of the IACUC findings shall be submitted to the IO and updated at least once every six months upon completion of the required semiannual evaluations.

The IACUC conducted a facility inspection and review of the facility program for animal care and use on May 9, 2009. The next inspection and program review occurred on January 15, 2010. These inspections and program reviews were conducted 8 months apart and exceeded the mandatory 6 month requirement under the Animal Welfare Act. Subsequently, the required reports to the IO also exceeded the maximum 6 month requirement.

The IACUC must conduct facility inspections and program reviews and submit the results of these findings to the IO at least every 6 months to ensure appropriate facility evaluations are maintained by the IACUC. Timely reports to the IO are essential for adequate communicatio from the IACUC to the IO regarding facility status according to the Animal Welfare Act.

Correct by: All future IACUC inspections, program reviews and reporting requirements must be conducted and fulfilled at least every 6 months.
