(e) Storage. Supplies of food and bedding must be stored in a manner that protects the supplies from spoilage, contamination, and vermin infestation. The supplies must be stored off the floor and away from the walls, to allow cleaning underneath and around the supplies. Food requiring refrigeration must be stored accordingly, and all food must be stored in a manner that prevents contamination and deterioration of its nutritive value.

- The refrigerated food storage room in the Psychology Building has water condensing on the walls and ceiling and is wetting the surfaces of the bags of food to the point that that one had to be removed.
- Food items (bagged chow) that becomes wet is subject to molding and deterioration.
- Correct the condensation in this refrigerated room.

(a) Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals.

- There were nails protruding from posts and boards in pen #7 of Building #628 which houses 2 goats.
- Sharp points (nails, etc) can injure the animals.
- This is a repeat item and as such should have been corrected by previous correction date of 6 August 2006.

- The room where the food for the goats in pen #7 of Building 628 was stored was dirty with no working light for proper inspection, tracks of vermin outside, and holes in the walls large enough to admit rats and mice.
- Proper storage rooms or containers are essential for protection of animal food from contamination.
- Insure that clean, well lighted facilities are used for the proper storage of animal food.

(a) The food shall be wholesome, palatable, and free from contamination and of sufficient quantity and nutritive value to maintain all animals in good health.

- The food for the goats in building #628 is what appears to be a poultry mash. There are two bags in the food storage room. One of these bags was open and not contained in a sealable container. There was some of this mash in a barrel with a wood top. A sample of this food was examined and found to be infested with weavils in various stages of molting.

- Animals need to have wholesome food per the above regulation to prevent disease.
- Correct this noncompliant husbandry item immediately.
