INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

The regulations state, "IACUC Functions.(6) Review and approve, require modifications in (to secure approval), or withhold approval of those components of proposed activities related to the care and use of animals...."

***In February, 2010, the IACUC learned that animal use had occurred without an approved protocol. While the use was non-invasive, it still must be reviewed and approved by the IACUC prior to any animal work. The IACUC and the IO agreed on 3 sanctions for the PI (two of which involved retraining), but it is 3 months later, and the PI still has not complied with at least 2 of the sanctions. It is essential for the IACUC to review and approve all animal use to ensure that animal welfare issues are addressed and to ensure compliance with the federal regulations. The IACUC also needs to have sufficient authority to ensure that these situations do not occur again.
