The regulation states, "Provision shall be made for the removal and disposal of animal and food wastes, bedding, dead animals, trash and debris....as to minimize vermin infestation, odors, and disease hazards."

***At the time of inspection, a cart with surgical items on top was present in the drug storage room. The items had been used in a surgical procedure several weeks earlier. A used IV catheter and a dirty tracheal tube were noted on the cart. Invasive equipment (tracheal tubes) used on animals should be cleaned immediately after use to protect the health and welfare of the following animal. Used IV catheters should be disposed of immediately.
