Section 2.31(d) IACUC review of activities involving animals. (1) In order to approve proposed activities or proposed significant changes in ongoing activities. . . The IACUC shall determine that the proposed activities or significant changes in ongoing activities meet the following requirements: (iv) Procedures that may cause more than momentary or slight pain or distress to the animals will: (C) Not include the use of paralytics without anesthesia.

1. Review of Animal Use Protocol 09-015 that described a study to evaluate a surgical device and instruments involving goats: The proposal stated incorrectly that a neuromuscular relaxant can be used to induce anesthesia. The record for goat #71 did not indicate that a neuromuscular relaxant was administered to the animal.

The Institutional Animal Care and Use Committee (IACUC) should ensure that a proposal to conduct an animal activity does not include the use of a neuromuscular blocking agent without adequate anesthesia to prevent discomfort, pain and/or distress to the animals.

1. Building G, instrument preparation area/corridor to operating room: A section of the common wall with the mechanical room was structurally open which may result in the possible entry of dirt, debris, and vermin into the operating room area. [Section 2.33(b)(1)]

The operating room area should be structurally sound and maintained in good repair to facilitate cleaning/sanitization and the maintenance of aseptic conditions in the operating room.

The research facility should make the necessary repairs.

2. Expired drug in the research facility. Office, lockbox: Fentanyl transdermal patch, 75 mcg/hr., lot #0706111, expired 3/2009 (1 box). [Section 2.33(b)(2)]

The use of expired drugs, fluids, and medical materials is not considered to be acceptable veterinary practice and may adversely affect animal treatment.

Correct by: Item 1> Wall repaired at time of site visit. Item 2> Expired drug removed for disposal at time of inspection.

INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(e) A proposal to conduct an activity involving animals, or to make a significant change in an ongoing activity involving animals, must contain the following: (4) A description of procedures designed to assure that discomfort and pain to animals will be limited to that which is unavoidable for the conduct of scientifically valuable research, including provision for the use of analgesic drugs. . .to minimize discomfort and pain to animals.

1. Review of Animal Use Proposal 07-064 that described a stifle joint study involving goats: The proposal failed to describe the clinical signs/criteria for assessment of postprocedural pain for continued administration of analgesic treatment. Review of available records for goat #126 indicated that analgesic treatment was continued when indicated although the criteria for treatment was not described in the proposal.

The Institutional Animal Care and Use Committee (IACUC) should ensure that a proposal to conduct an animal activity includes a complete description of procedures intended to avoid or minimize discomfort, pain and/or distress to the animals. All procedures must be reviewed and approved by the IACUC to ensure the appropriate care and use of the animals.
