This letter is being written to inform you of an amendment that should be made to the 2007-2008 USDA annual report filed by Minnesota State University Moorhead, Customer ID 794, Certificate No: 41-R-0049.

After filing the 2007-2008 report we learned that [b2 high, b7F] was added to our certificate as site #2. The address of the animal facility at site #2 is: [b2 high, b7F] Facility, Department of Biological Sciences, Minnesota State University Mankato, Mankato, MN 56001. [b2 high, b7F] used one rabbit during the 2007-2008 reporting period and the one rabbit was not included in column C, line 6. Thus column C, line 6 should read 3 rabbits instead of 2 and column F, line 6 should read 3 instead of 2. Thank you for your attention to this matter.
