On 17 March 2009 a dog escaped its' handler out of doors and was hit by a car. The handler used only one leash on the animal and was trying to collect a urine sample from the dog at the time of the incident. The incident resulted in the dogs death.

The facility failed to protect the welfare of the animal by not ensuring all personnel were adequately trained in handling procedures.

Correction: The facility has implemented a corrective action for the handling of animals by formulating a written policy on animal handling and that all animal handlers must sign a notice of agreement to follow all of the facilities policies.

This affected one animal.

The one rabbit (spotted gray and white, approximately 1.5 lbs) viewed on inspection was housed in a primary enclosure that measured only 12 inches in height.

Rabbits need primary enclosures at least 14 inches in height. This allows for normal postural movements and behavior ensuring the husbandry of the animal and its health and wellbeing.

Provide a primary enclosure for the rabbit housed at the facility that is at least 14 inches in height and has at least 1.5 square feet of space.

Correct by: 21 July 2008. This affects 1 animal indirectly.

Note: Facility will provide exercise of the rabbit until new caging is acquired.

#### PRIMARY ENCLOSURES.

Resting surfaces. Each primary enclosure housing cats must contain a resting surface or surfaces that, in the aggregate, are large enough to hold all the occupants of the primary enclosure at the same time comfortably. The resting surfaces must be elevated, impervious to moisture, and be able to be easily cleaned and sanitized, or easily replaced when soiled or worn. Low resting surfaces that do not allow the space under them to be comfortably occupied by the animal will be counted as part of the floor space.

The primary enclosures housing 3 cats individually at the facility did not have elevated resting surfaces. This did not allow the animals an elevated surface to rest on. The enclosures had an elevated grate system that comprised the entire floor space of the enclosure.

Primary enclosures must have elevated surfaces to allow for the cats' comfort and to ensure their health and well-being.

Provide elevated resting surfaces for the cat primary enclosures.

Correct by: 31 March 2009. This affected 3 animals indirectly.
