#### INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Review, at least once every six months, the research facility's program for humane care and use of animals, using title 9, chapter 1, subchapter A--Animal Welfare, as a basis for evaluation.

The meeting minutes reviewed for 15 February 2007, 31 May 2007, and 1 November 2007 reflect that the Review of the Humane Care and Use program was performed on 15 February 2007 and on 1 November 2007. This is approximately 8.5 months in between reviews. This timeframe is greater than the 6 months frequency of review as required by AWA regulations.

The IACUC needs to ensure that reviews are performed at least once every 6 months as required by AWA regulation to ensure that the program is current ensuring the health and wellbeing of the animals at the facility.

Ensure that the IACUC performs the Review of the Humane Care and Use Program at least once every 6 months.
