### 2.31 (d) (1) (ii)

#### **INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).**

The principal investigator has considered alternatives to procedures that may cause more than momentary or slight pain or distress to the animals, and has provided a written narrative description of the methods and sources, e. g., the Animal Welfare Information Center, used to determine that alternatives were not available.

Training protocol 08-167, approved April 2008, contains procedures where the principal investigator will be using a vasodilator/sedative to "calm the animal". The protocol did not contain a written narrative describing the methods used to search for alternatives to painful and distressful procedures.

The IACUC needs to ensure that all protocols submitted that involve painful or distressful procedures contain a written narrative describing the methods used to search for alternatives to the painful or distressful procedures. This ensures that animals are not used inappropriately in research.

Ensure all protocols submitted to the IACUC containing painful and distressful procedures contain the necessary written narrative describing the search for alternatives to painful and distressful procedures.

Correct from this time forward. This potential affects 30 animals indirectly.

### 2.31 (d) (5)

#### **INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).**

The IACUC shall conduct continuing reviews of activities covered by this subchapter at appropriate intervals as determined by the IACUC, but not less than annually.

There were two protocols reviewed during this inspection, 06-98 approved August 2006 and 00-98 approved May 2006 and amended July 2006, that did not have reviews done at least annually for this year (08) and last year (07) by the IACUC. These protocols are still active.
