INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

2.31d(2) Prior to IACUC review, each member of the Committee shall be provided with a list of proposed activities to be reviewed. Written descriptions of all proposed activities that involve the care and use of animals shall be available to all IACUC members, and any member of the IACUC may obtain, upon request, full Committee review of those activities. If full Committee review is not requested, at least one member of the IACUC, designated by the chairman and qualified to conduct the review, shall review those activities, and shall have the authority to approve, require modifications in (to secure approval), or request full Committee review of any of those activities. If full Committee review is requested for a proposed activity, approval of that activity may be granted only after review, at a convened meeting of a quorum of the IACUC, and with the approval vote of a majority of the quorum present...

The IACUC currently uses a method to review proposed activities in which IACUC members are mailed or electronically mailed a complete copy of the proposal. The IACUC members then will relay their approval or disapproval of the proposal to the IACUC chair and then if all approved the activity, it is allowed to commence. The IACUC the reviews the proposal again at the next regular convened semi-annual meeting. The Animal Welfare Act requires a convened meeting for all full committee reviews to allow meaningful deliberation. Proposals shall be reviewed by the full committee at a convened meeting or by a member assigned by the chair to be designated reviewer after all members have had an opportunity to call for a full meeting and none have done so. Correct from this day forward.
