HOUSING FACILITIES, GENERAL.

(c) Surfaces--

(2) Maintenance and replacement of surfaces. All surfaces must be maintained on a regular basis. Surfaces of housing facilities--including houses, dens, and other furniture-type fixtures and objects within the facility--that cannot be readily cleaned and sanitized, must be replaced when worn or soiled.

Throughout the canine facility, there were approximately 10 dog beds that require maintenance. One bed had a torn cloth insert that may no longer support the weight of the dog and two others had bent legs that could collapse if a dog climbed onto these beds. The other beds were made of plastic and had been excessively chewed by the dogs. These rough, chewed surfaces can not be effectively cleaned and sanitized and may have some sharp edges. Facility evaluation for maintenance issues must be performed on a regular basis. All furniture items, toys, or houses must be repaired or replaced when they become worn or damaged. To be corrected by September 28, 2007.
