At least two IACUC approved animal use activities were not reviewed at least annually by the IACUC. Protocol 06MCC005 was approved in September 2006 and has not had a continuing review by the IACUC since the original approval date. Protocol 07UNM011 was approved in April 2007 and has not had a continuing review by the IACUC since the original approval date.

The IACUC should establish a mechanism to ensure reviews occur for all activities involving animals at least annually. The continuing annual reviews of animal use activities by the IACUC is needed to ensure that what was approved by the IACUC is what the Principal Investigator (PI) has been doing and that, should any changes be needed, the IACUC can address these as quickly as possible with the PI to assure humane care and use of the animals.
