Protocol 2007-079 involves an eye procedure, the investigator indicates that during the procedure, proparacaine will be used, but does not mention any follow up method to monitor discomfort or pain of the animal and to relieve it.

The IACUC shall ensure that the principal investigator provide a description of how they will monitor and relieve pain and distress.
