Animal M02417 underwent a procedure on 12/4/08 there is no indication when the animal was extubated also there is no documentation of monitoring of reflexes as indicated in the protocol from 10:30am till 15:20pm

Animal RUQ10 had a procedure 1/15/09 there is no indication as to when it was extubated
