### 2.31 (d) (2)

#### INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(d)(2) IACUC: Prior to IACUC review, each member of the Committee shall be provided with a list of proposed activities to be reviewed. Written descriptions of all proposed activities that involve the care and use of animals shall be available to all IACUC members, and any member of the IACUC may obtain, upon request, full Committee review of those activities. If full Committee review is not requested, at least one member of the IACUC, designated by the chairman and qualified to conduct the review, shall review those activities, and shall have the authority to approve, require modifications in (to secure approval), or request full Committee review of any of those activities.

An amendment with a proposed significant change for animal activity proposal 1064W was approved by a designated reviewer in May of 2007 prior to notifying the IACUC members of its submission and the members having the opportunity to request a full committee review. The IACUC members must be provided with a list of proposed activities to be reviewed such as new proposals, annual reviews and significant amendments to have the opportunity to request written descriptions of the proposed activities and/or call for a full committee review to comply with the Animal Welfare regulations.
