Section 2.31(e)(3) IACUC: A proposal to conduct an activity involving animals must contain a complete description of the proposed use of the animals.

Animal activity proposal 2003-241 describes three experiments including a summary of the surgical procedures on pages 7-8. Pages 11-18 of the proposal include some additional procedures and a different summary of surgical procedures. The proposal needs to be consistent and contain a complete description of the proposed use of the animals so the IACUC can ensure that animal pain and distress is minimized.

INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(e) IACUC: A proposal to conduct an activity involving animals must contain the following:

- (1) The approximate number of animals to be used;
- (2) A rationale for the appropriateness of the number of animals to be used.

Animal activity proposal 2007-054 was unclear for the justification of animal numbers. The principal investigator stated during the inspection that the number of animals requested was the number of animals expected to be housed at the facility at the same time and not the number of animals to be used. The proposal needs to contain the number of animals to be used and the rationale for the appropriateness of the number of animals.
