ENVIRONMENT ENHANCEMENT TO PROMOTE PSYCHOLOGICAL WELL-BEING.

Dealers, exhibitors, and research facilities must develop document and follow an appropriate plan for environment enhancement for non-human primates. Certain primates must be provided special attention regarding enhancement for example those that show signs of being in psychological distress.
At the time of inspection one primate C30024 was noted to have hair loss, a check of the records showed the animal had a hair picking problem. The Plan does address how to deal with this abnormality but the records does not show the continuity for the treatment, between Feb 1 08 and Feb 6, 08 .
The enrichment plan needs to be documented on a daily basis in particular if there are special considerations.
