#### **INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).**

IACUC review of activities involving animals. (1) In order to approve proposed activities or proposed significant changes in ongoing activities, the IACUC shall conduct a review of those components of the activities related to the care and use of animals and determine that the proposed activities are in accordance with this subchapter unless acceptable justification for a departure is presented in writing;

\*\*\*There is no adequate IACUC approved protocol for activities involving surgical training of physicians using new devices. Appropriate protocols should describe all activities and contain required justifications based on the nature of the activity. Currently, physician training for the use of new devices is covered under a general surgical protocol that does not contain adequate justifications for species, and numbers of animals used and does not adequately address consideration of alternatives (models, cadavers, etc.). Need to ensure all activities, including training, are appropriately considered and approved by the IACUC. Correct by February 1, 2010 or before any further training is done.

### 3.131 (a)

#### SANITATION.

(a) Cleaning of enclosures. Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors. When enclosures are cleaned by hosing or flushing, adequate measures shall be taken to protect the animals confined in such enclosures from being directly sprayed with the stream of water or wetted involuntarily.

\*\*\*Swine enclosures were being cleaned by hose with a power-spray nozzle at time of inspection. The design of the enclosures and number of swine in each enclosure does not allow for hosing of enclosures without involuntary wetting of animals. Hosing of enclosures must be conducted in a manner that prevents animals from being involuntarily sprayed by the hose. Correct by: 17 Apr 08.
