The drug cabinet contained an assortment of drugs with syringes or needles alone remaining in the cap. These vials were mixed as far back as two years ago. The cap on at least one vial was deteriorating badly, it was to the point of allowing in the room air without restriction. There were used syringes in the cabinet. Drugs for injection must be maintained in sterile containers especially if the enclosed drug is considered to have a long life span. Contaminated drugs cannot be used for injection.
