****The last two semiannual reports list deficiencies in the facility on the checksheets. The actual report to the IO indicates that there are no minor or major deficiencies in the facility. There are no correction dates listed for the items noted. The items cited included cleaning, facility repairs, etc. that needed accomplished. All of this is required in the reporting to the IO. This must be correctly done on all future semiannual reports to provide for the health and well-being of the animals..

SANITATION.

(a) Cleaning of enclosures. Excreta shall be removed from primary enclosures as often as necessary to prevent contamination of the animals contained therein and to minimize disease hazards and to reduce odors. When enclosures are cleaned by hosing or flushing, adequate measures shall be taken to protect the animals confined in such enclosures from being directly sprayed with the stream of water or wetted involuntarily.

The vole enclosures with large litters were extremely dirty. There was an excessive buildup of feces to the point that the animals could not escape contact with their own feces and urine. This is especially of concern as the animals involved are unweaned young. This must be done more frequently than weekly to protect the animals from contamination and to protect their health.

***The cage wash area was still extremely dirty. The floor and ramp areas contained heavy remains of feces, hair and other debris that need removed.

This dirt buildup has permitted insects to move into this area.

The drains in this area are deteriorating due to the chemicals. The rust is eating the metal. They need treated to prevent further damage.

This area requires a thorough cleaning to protect the animal equipment from contamination.

The animal rooms are dirty, dusty and in need of a thorough cleaning of the floors, tables and counters. There was a buildup of dust, animal feces and debris in the vole areas through out the facility. These areas must be maintained clean to protect the animals health and well-being.

There were several dirty and rusty carts through out the facility. These need repaired/ replaced to be readily cleanable/ disinfectable to make them readily sanitizeable.

(ii) The principal investigator has considered alternatives to procedures that may cause more than momentary or slight pain or distress to the animals, and has provided a written narrative description of the methods and sources, e. g., the Animal Welfare Information Center, used to determine that alternatives were not available;

Protocol 06-12A - this protocol conducted searches for alternatives to painful procedures for items that did not require searches and failed to conduct a search for the very likely injury to pups that will result by placing pups with other parents. This is even noted in the protocol. A search for alternatives to this more than momentary or slight pain and distress to these pups must be conducted.

Protocol 07-1B This protocol conducted a search for alternatives to painful procedures that did not include adequate keywords in the search. Even the word vole was not used. It also had only a very brief one sentence discussion of the search strategy that really did not provide sufficient information. The discussion of search strategy and results should adequately describe what was done during the search from the selection of key words and search engines used to a discussion of the results so that the IACUC has a clear concept of what was done and why they reached the decision they did.

These protocols and any protocols with similar problems need addition work done with their searches.
