ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE.

Section 2.33(b) Each research facility shall establish and maintain programs of adequate veterinary care that include:
(2) The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries.

1. Veterinary Services Building, animal room, housing 5 dogs: Four dogs, dog #4419391, #4516907, #4542967, #473415, were observed to have moderate dental plaque/calculus and mild to moderate gingival/periodontal disease. Periodontal disease may cause discomfort and may lead to loss of periodontal tissues/teeth or other disease. The APHIS official was told dental scaling/periodontal therapy was last performed about one year ago.

Adequate veterinary care should include periodic oral/dental examination and dental care to prevent and/or to provide treatment for periodontal disease. Animal monitoring and dental care procedures should be performed as often as necessary to better control periodontal disease.
