INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(c)(3) IACUC: The IACUC reports to the Institutional Official must contain a description of the nature and extent of the research facility's adherence to this subchapter, must identify specifically any departures from the provisions of title 9, chapter I, subchapter A--Animal Welfare, and must state the reasons for each departure. The reports must distinguish significant deficiencies from minor deficiencies. If program or facility deficiencies are noted, the reports must contain a reasonable and specific plan and schedule with dates for correcting each deficiency.

The IACUC meeting minutes for November 2006 list numerous observations from the facility inspection regarding items that need to be corrected. However, the IACUC report to the Institutional Official includes only two minor deficiencies. The Institutional Official received a copy of the minutes, but the IACUC report to the Institutional Official needs to include all the deficiencies found during the facility inspection so each deficiency is designated as significant or minor with a correction plan and date to comply with the Animal Welfare regulations to ensure compliance. ANNUAL REPORT.

Section 2.36(b) Annual report: The annual report shall:

(5) State the common names and the numbers of animals upon which teaching, research, experiments, or tests were conducted involving no pain, distress, or use of pain-relieving drugs. Routine procedures (e.g., injections, tattooing, blood sampling) should be reported with this group;

(6) State the common names and the numbers of animals upon which experiments, teaching, research, surgery, or tests were conducted involving accompanying pain or distress to the animals and for which appropriate anesthetic, analgesic, or tranquilizing drugs were used;

The facility's annual report for 2006 included animals purchased for research during the reporting period but did not include the rabbits and sheep that were already being used for research on October 1, 2005. The numbers of goats reported in the columns C and D could not be explained during this inspection. The annual reports for research facilities need to be accurate to comply with the Animal Welfare regulations. The facility needs to submit an amended

(c) Storage. Supplies of food and bedding shall be stored in facilities which adequately protect such supplies against infestation or contamination by vermin. Refrigeration shall be provided for supplies of perishable food.

****There was feed and bedding for the rabbits and other animals in the quarantine facility stored in a severely cluttered area that had a severe rodent problem. There were large numbers of rodent feces observed.

Note: the rabbits and their feed were removed from this area, but the hay and bedding for the other species remain. All feed from this area will remain out of use for all species and will be destroyed. This still needs to be cleaned and rodent abatement efforts improved to protect the health and well-being of the animals.

INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

A proposal to conduct an activity involving animals, or to make a significant change in an ongoing activity involving animals, must contain the following: (1) Identification of the species and the approximate number of animals to be used; (2) A rationale for involving animals, and for the appropriateness of the species and numbers of animals to be used; (3) A complete description of the proposed use of the animals; (4) A description of procedures designed to assure that discomfort and pain to animals will be limited to that which is unavoidable for the conduct of scientifically valuable research, including provision for the use of analgesic, anesthetic, and tranquilizing drugs where indicated and appropriate to minimize discomfort and pain to animals; and (5) A description of any euthanasia method to be used.

The core protocols do not contain all of the information required above. All of the above information must be included and complete enough for the IACUC to make informed decisions with regard to the welfare of the animals. Item four corresponds with the requirement for searches but this aspect of the search is missed by the current review form. Correct By: 30 November 2008

PRIMARY ENCLOSURES.

Primary enclosures shall be constructed and maintained so that the rabbits contained therein have convenient access to clean food and water as required in this subpart.

Several enclosures had openings that were not covered to prevent the rabbits from getting body parts outside the enclosure. Others had sagging floors that could allow the animals to get a limb caught. Daily observation for disease and cleaning needs to include assesment of the enclosures (size, structure, assembly) to assure the well being of the animals. 3 October 2008

A proposal to conduct an activity involving animals, or to make a significant change in an ongoing activity involving animals, must contain the following: (3) A complete description of the proposed use of the animals.

The core protocol involving antibody production does not contain complete descriptions of the bleeding procedure or the injection of antigen and Freund's adjuvant. A complete description is required to assure that the IACUC has a clear picture of the procedures when determining if they are acceptable for approval to prevent undue pain and distress. The Protocol may refer to an IACUC approved SOP or guideline for routine procedures if they contain a complete description. The current SOPs for the two items above do not contain complete descriptions and are not referenced in the protocol. Correct by: Next protocol review
