PRIMARY ENCLOSURES.

Section 3.28(a)(1) General: Primary enclosures, including their racks, shelving and other accessories, shall be constructed of smooth material substantially impervious to liquids and moisture.

The wheel casters on several enclosure racks were severely rusted and some had missing metal exposing a cracked rubber/plastic material above the wheel. These wheel casters need to be repaired or replaced to be substantially impervious to moisture and able to be adequately cleaned and sanitized to maintain the health of the animals.
