### 2.31 (b) (4)

#### INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(b)(4) states "IACUC Membership. If the Committee consists of more than three members, not more than three members shall be from the same administrative unit of the facility."

The IACUC is currently composed of 9 members, 5 of whom are in the Biology Department. No more than three members from the Biology Department can be on the committee.

#### ANNUAL REPORT.

Section 2.36(b)(5) states "The annual report shall: State the common names and the numbers of animals upon which teaching, research, experiments, or tests were conducted involving no pain, distress, or use of pain-relieving drugs. Routine procedures (e.g., injections, tattooing, blood sampling) should be reported with this group."

A trap and release field study involving eastern wood rats has been conducted for the past several years, but the number of animals used in the study was not reported on the USDA Annual Report. An amended report needs to be submitted to the Regional Office showing the correct numbers of animals used this past year.
