INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(c)(1) states "IACUC Functions. With respect to activities involving animals, the IACUC, as an agent of the research facility, shall inspect, at least once every six months, all of the research facility's animal facilities, including animal study areas, using title 9, chapter I, subchapter A-Animal Welfare, as a basis for evaluation; Provided, however, That animal areas containing free-living wild animals in their natural habitat need not be included in such inspection."

Facility inspections have not been conducted at least once every six months. The first one was done on 6-1-07; the next on 1-28-08, 7 months apart. The next one is scheduled for this month, 8 months since the last inspection. The facility inspections need to be conducted at least once every six months. To be corrected by getting on schedule after this next inspection.

2.31 (c) (2)

INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(c)(2) states "IACUC Functions. With respect to activities involving animals, the IACUC, as an agent of the research facility, shall review at least once every six months, the research facility's program for humane care and use of animals, using title 9, chapter I, subchapter A--Animal Welfare, as a basis for evaluation."

The last program review was conducted on 1-28-08. Another program review should have been held by 7-28-08, to be within the required 6 months. A program review is scheduled for this month.

2.31 (c) (3)

INSTITUTIONAL ANIMAL CARE AND USE COMMITTEE (IACUC).

Section 2.31(c)(3) states "IACUC Functions. With respect to activities involving animals, the IACUC, as an agent of the research facility, shall prepare reports of its evaluations conducted as required by paragraphs (c)(1) and (2) of this section, and submit the reports to the Institutional Official of the research facility. The reports shall be reviewed and signed by a majority of the IACUC members and must include any minority views. The reports must contain a description of the nature and extent of the research facility's adherence to this subchapter, must identify specifically any departures from the provisions of title 9, chapter I, subchapter A--Animal Welfare, and must state the reasons for each departure. The reports must distinguish significant deficiencies from minor deficiencies. A significant deficiency is one which, with reference to Subchapter A, and, in the judgment of the IACUC and the Institutional Official, is or may be a threat to the health or safety of the animals. If program or facility deficiencies are noted, the reports must contain a reasonable and specific plan and schedule with dates for correcting each deficiency."

This institution started an IACUC this year. A report was sent to the Institutional Official describing the first facility inspection done by two members of the committee and a general program description was provided by the IACUC chair. The report did not state if deficiencies found were significant or minor and did not include correction dates. The report was e-mailed to the IACUC members and their e-mailed responses were included with the report, but this does not fulfill the requirement for signatures of a majority of the members. Future reports need to contain all the above required information and be signed by a majority of the IACUC members.
