PRIMARY ENCLOSURES.

Sec. 3.6 Primary enclosures.

Primary enclosures for dogs and cats must meet the following minimum requirements:(a) General requirements...
(2) Primary enclosures must be constructed and maintained so that they:...(ix) Enable all surfaces in contact with the dogs and cats to be readily cleaned and sanitized in accordance with Sec. 3.11(b) of this subpart, or be replaceable when worn or soiled;

One front corner wooden post of an indoor dog enclosure was noted to be scratched and chewed to the extent that bare wood was exposed and splintering was present. The presence of bare splintered wood makes the enclosure not readily cleanable and sanitizable and may lead to injury to the dogs. All enclosures must be maintained such that all surfaces in contact with the dogs can be readily cleaned and sanitized as required in the regulations or they need to be replaced when worn. Correct by Sept. 1, 2009.

MISCELLANEOUS.

2.38(g) Identification of dogs and cats.

(1) All live dogs or cats, including those from any exempt source, delivered for transportation, transported, purchased or otherwise acquired, sold, or disposed of by a research facility, shall be identified at the time of such delivery...

*One cat arrived on 2/26/08 for a neuter surgery. Rather than being returned to the shelter after completion of the surgery, it is being housed at the facility awaiting transportation out of state. It is not currently identified by an official USDA tag, tattoo or microchip.

*All dogs and cats need to be properly identified to establish legal and medical histories.

*All live dogs and cats not at the facility under a client-patient treatment relationship basis need to be identified by official USDA tag, tattoo or microchip at the time of arrival at the facility.

HOUSING FACILITIES, GENERAL.

3.1(a) Structure; construction. Housing facilities for dogs and cats must be designed and constructed so that they are structurally sound. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

*A loose ceiling tile was noted in the cat room with an opening between the attic area and the room. Apparently stray cats enter into the building through an opening between the old barn and building and then enter the cat room through the loose ceiling tiles. Another ceiling tile appeared bowed.

*Loose ceiling tiles may fall and cause injuries. Stray animals entering the facility housing cats may lead to spread of disease and pest issues.

*The ceiling tiles need to be kept in good repair. The building housing the cats needs to be kept in good repair to restrict other animals such as stray cats from entering.
