(a) Structure: construction. Housing facilities for nonhuman primates must be designed and constructed so that they are structurally sound for the species of nonhuman primates housed in them. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

It was noted during the routine inspection that three overhead florescent light covers were broken and needed to be replaced. Management informed me that the light covers would be replaced by the end of the week.

PRIMARY ENCLOSURES.

Sec. 3.80 Primary enclosures.

Primary enclosures for nonhuman primates must meet the following minimum requirements:

- (a) General requirements.
- (2) Primary enclosures must be constructed and maintained so that they:
 - ii) Protect the nonhuman primates from injury.

It was noted in several rooms housing non-human primates to contain primary enclosures that allowed the animals to reach outward into other nearby enclosures that contained primates. Several rooms contained cages to close which predisposes the animals to be bitten by other primates. Need additional space for housing the primates.
