
\*\*\*There was an emergency kit on site, available for use, however the majority of the drugs contained in the kit were expired. There were 3 bottles of epinephrine with expiration dates of 11/09, 1/08, and 5/08; 1 bottle of dopamine with an expiration date of 9/09; 1 bottle of lidocaine with an expiration date of 6/09; and atropine with an expiration date of 8/08. Additionally, no list of drug dosages and/or uses for the drugs in the kit could be found on site. Advance planning is especially important when animal use occurs in remote field locations with a veterinary technician at the location and veterinary guidance available only by phone.
