SANITATION.

(b) Sanitization of primary enclosures. (1) Primary enclosures for rabbits shall be sanitized at least once every 30 days in the manner provided in paragraph (b)(3) of this section.

(3) Primary enclosures for rabbits shall be sanitized by washing them with hot water (180 [deg]F.) and soap or detergent as in a mechanical cage washer, or by washing all soiled surfaces with a detergent solution followed by a safe and effective disinfectant, or by cleaning all soiled surfaces with live steam or flame.

***No assurances are being provided that the cage washer temperature is reaching 180 degrees fahrenheit as required by regulation. There is no service contract in place which would accomplish routine calibration, no temperature log is being generated by the machine or manually, no temperature strips are being run through the machine and no plates are being incubated.

Routine calibration is required. along with some method of monitoring actual temperatures/ effectiveness. Correct within 30 days.
