#### HOUSING FACILITIES, GENERAL.

3.75 Housing facilities, general.

(a) Structure: construction. Housing facilities for nonhuman primates must be designed and constructed so that they are structurally sound for the species of nonhuman primates housed in them. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

The corner of the chainlink fencing on the top of the outside run of the 2nd enclosure in building 2 is loosening from its attachment to the building . The non human primates were observed bouncing off the top of the enclosure which caused this area to bow. This area needs to be repaired to ensure that the animals are protected from injury and do not escape the enclosure.

There were also sharp points observed on many of the metal wires which secure the chainlink fencing to the support poles of the enclosures. These sharp wires are potential areas for injury to the non human primates. All enclosures need to be checked for sharp points on wires and these removed to protect the non human primates from injury.
