FACILITIES, GENERAL.

"3.125 Facilities, general.

(a) Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. The indoor and outdoor housing facilities shall be structurally sound and shall be maintained in good repair to protect the animals from injury and to contain the animals."

A piece of woven wire fencing covers an east-facing barn window to keep the goats from entering the pig area. The fencing has exposed wire ends. A section of enclosure fencing on the east side of the barn has a loose length of woven wire alongside it.

Both of these areas pose a risk of injury from the exposed wire points, and the loose wire along the fence also poses a risk of entanglement to the animals contained therein.

The assistant who accompanied the inspection said that repairs could be made within a week's time -- correct by 4/6/2007.
