

...Why Disaster Training in the Pacific Northwest?...

With Mount St. Helens smoldering, the Cascade fault line shaking, rivers rising and the risk of forest and wild fires, we all need to be prepared to respond to a disaster. This training is essential for anyone who is concerned about animals in any kind of disaster. Whether you work at a shelter, fire department, police station, or are interested in assisting animals in disasters, this training will cover all issues vital to effective sheltering of animals in emergencies.

...about the training...

Emergency Animal Sheltering is intended to prepare volunteers to serve at emergency shelters for pets and animals evacuated or displaced from their homes because of a disaster. The course covers the different types of emergency animal shelters and the procedures, policies, skills, and personnel needed for each. The skills learned are useful in dealing with any large-scale animal disaster or sheltering situation.

The class includes one day of classroom instruction and demonstrations, a tabletop exercise, and a long half-day hands-on emergency sheltering scenario. Topics include introduction to disasters & emergency management, community planning, types of emergency shelters for animals, meeting the needs of the animals, logistics, human resources, worker health & safety, administrative issues including use of forms, legal issues, media/public relations, and closing the shelter.

...location...

Class runs on Saturday, September 30 from 9:00am -5:00pm (registration at 8:00am) and Sunday, October 1, from 9:00am to 3:00pm. The training will be held at the Spokane County Fair & Exposition Center, 404 N. Havana Street, Spokane Valley, WA 99202

...accommodations...

...what to bring...

Bring clothing comfortable for sitting in class for the first day and clothing appropriate to the weather for the second day, as the simulation will be held regardless of weather (travel permitting). Those with animal allergies should be aware that there will be a variety of animals at the simulation. Maps and basic personal equipment lists will be sent to registrants.

...registration...

The registration fee of \$ 35 includes two course days, materials, and refreshments. Class size is limited to 75 and a minimum of 35 registrants will be required to conduct the course. Registration must be received by September 8, 2006. If student withdraws before that date or if the course is cancelled by The HSUS, all tuition paid will be returned. If a student withdraws between

September 8 and 23, half refund; after Sept 23, no refunds.

...certification ...

Certificates of completion will be sent to those attending all sessions. Completion of this training does not constitute or imply membership on The HSUS National or Regional Disaster Animal Response Teams.
