## **Petland in Michigan: Where Do They Get Their Puppies?**

Petland claims that they only buy from breeders with “the highest standards,” but the Humane Society of the United States (HSUS) has found that they continue to buy from **known puppy mills** and **out-of-state brokers** that deal with puppy mills.

A **broker** is a “middleman” animal dealer that buys puppies from many different kennels and puppy mills for resale to pet stores.

#### **MAM Kennel: Filmed as Part of HSUS’s Initial Investigation**

The store received puppies directly from **Mike & Melanie Moore/MAM Kennel** in 2009, a puppy mill that has had numerous Animal Welfare Act violations and was filmed as part of our initial Petland Investigation.

#### **Out-of-State Sellers with Animal Welfare Act Violations**

The store also received shipments directly from Missouri, Kansas, Oklahoma, and Arkansas out-of-state sellers in 2009, some of whom have been cited for Animal Welfare Act violations.

#### **QD Kennel: Selling Over 5,000 Puppies a Year**

In 2009, this store received shipments from a large-scale commercial puppy broker in Missouri that ships puppies all over the United States. **QD Kennel** sells over 5,000 puppies a year and reportedly grosses over \$1,000,000 in sales.
